Dear Parents,

Welcome to Middlefork School. Kindergarten marks the beginning of your child's formal academic experience and, we hope, a lifelong love of learning. This is a very special time for you, your child, and for us. Enclosed in this packet are seven forms to be completed and returned to the office. A copy of your child's birth certificate must also be on file prior to the first day.

- An **enrollment record** to be completed and returned today.
- A **developmental history form** to be completed today or taken with you to complete at home. (We do need this form to be returned by June 1.)
- A **residency affidavit** certifying residency within Sunset Ridge School District 29 to be completed today.
- A **vision form** to be completed by a licensed optometrist or a physician who provides complete eye examinations.
- A **medical form** for a physical examination to be completed by your physician. Children entering kindergarten must show proof of a lead screen level and be current with required immunizations. Proof of your child having received one dose of chicken pox vaccine (varicella) on or after his or her first birthday is also required. A physician can confirm past disease history in lieu of vaccination.
- A **dental form** to be completed by your dentist after he or she has examined your child's teeth.
- An **emergency form** to be completed today or taken with you to complete and return.

We look forward to seeing you and your child for Kindergarten Visitation Day on Thursday, May 31, 2012. You are welcome any time between 3:15-4:30 and 6:00-7:00 p.m.
